Discuss an ordinance of the City of Sachse, Texas, amending the code of ordinances by amending chapter 7 "personnel" by amending section 7-2 titled "Park and Recreation Commission" by amending 7-2(d) titled "powers and duties" to include the naming of public facilities managed by the Parks and Recreation Department; amending 7-2(e) titled "Policies. Rules and regulations for utilization of all city parks and facilities" to prohibit smoking and tobacco use in city parks; to include the City Complex Amphitheater as a facility covered under the rules and regulations; and adding a new section 7-2(e) (5) to establish user fees for recreation facilities by City Council resolution; providing for a penalty of fine not to exceed the sum of five hundred dollars (\$500.00) for each offense; and providing an effective date.
