#### **Executive Summary**

The City's Street Budget includes funds for concrete repairs and replacement improvements. These repairs include panel replacement, sidewalk repairs, curb repairs, and other concrete repairs. The City typically bids the concrete repairs each year, which takes time and significant effort. The City approved an Interlocal Cooperative Purchasing Agreement with the City of Grand Prairie to piggy back on contracts they have bid and awarded. The City plans to "piggy back" on a concrete repair and replacement contract Grand Prairie recently awarded to McMahon Contracting.
