<u>13-1379</u> Conduct a public hearing and consider the application of William S. Rheaume, requesting a variance to Planned Development 10 (Ord. No. 1443), Section 2.12(H) to decrease the minimum rear yard setback from 15-feet to 11'-2" to allow for the construction of a covered patio. This property is described as Lot 4, Block F, Woodbridge Phase 7B and is located at 6418 Crestmoor Lane, Sachse, Texas 75048.

Chapter 11, Article 3, Section 2.4, Table (2).A to increase the maximum allowable accessory building size from 400 square feet to 1,200 square feet and to permit the use of metal exterior wall building materials in the construction of an accessory building. This property is described as Lot 28, Block H, Park Lake Estates Phase 2 and is located at 3710 Trailridge Drive, Sachse, Texas 75048.
