Executive Summary

The City of Sachse has recently collected money for the Park Development Fund. The balance in this fund is \$350,714 and is available to be used for improvements to Parks, Playground, Ball Fields, and other Parks and open space projects. The Parks and Recreation Board discussed at the February 13, 2014, meeting using the Park Development Fund for several park projects. The Board unanimously voted to have staff bring a request to Council to use these funds to complete Firefighters Park, add a shade structure over the playground at Salmon Park and combine funds with the Sachse Baseball Association to build a shade structure over the bleacher seating at Salmon Park.

Executive Summary

The applicant is requesting a change in the Future Land Use Plan designation for the property from Rural Residential to Low Density Residential. The impetus for the requested change is that the Future Land Use designation is not consistent with the proposed zoning designation that is part of a companion zoning request. Since the Zoning designation must be consistent with the Future Land Use designation, the Future Land Use change must be considered prior to the Zoning change.

<u>14-2094</u> Consider the postponement of an Ordinance of the City of Sachse,

Executive Summary

A public hearing was held by Planning and Zoning Commission for this item on March 10, 2014. This item was originally advertised to be considered at this meeting on March 17, 2014; however, Planning and Zoning Commission recommended denial of this request thus prompting additional legal advertisement requirements dictated by the City of Sachse Zoning Ordinance. The legal advertisement requirements as dictated by the Zoning Ordinance were not able to be completed in sufficient time to permit this item to be considered by City Council on March 17, 2014; therefore, this item is being postponed to April 21, 2014.
