Consider acceptance of the Quarterly Budget and Investment Reports for the quarter ended September 30, 2014.

Executive Summary

Cash on hand at 09/30/2014 was \$23,510,346 in all funds; of this amount \$18,510,346 was available for investing. The remaining \$5,000,000 is held in a non-interest bearing analysis account per contract with American National Bank. The average interest/yield on all investments was .28%, and investment earnings totaled \$14,346.

General Fund revenues are at 106% of budget and expenditures are at 94% as of 09/30/2014. Utility Fund revenues are at 89% of budget and expenditures are at 91%. General Fund revenues are over budget due to higher than expected activity in building permits, plan review, and development fees. Utility Fund revenues are significantly below budgeted amounts due to the extension of Stage 3 Drought restrictions; expenses are also lower than projected.

At the October 6, 2014 City Council meeting, the City Council of the City of Sachse approved a resolution to approve the Facilities Agreement with Woodbridge XVII, Ltd. and Woodbridge XIX, Ltd. for the design and construction of public roads in the City of Sachse, Texas. After the agreement was approved by the City Council, the Developer requested that the insurance requirements in the agreement be clarified for the different entities involved. Staff worked with the City Attorney to more clearly state the insurance requirements for the design engineer and the insurance requirements for the contractor separately in the agreement. Since the agreement had not yet been executed, this is not an amended agreement.
